## RA23/009 Parks & Playgrounds

a) The Committee noted the grounds report, a discussion took place over the renewal of the pond lease, it was agreed that the Clerk would go back to Buckinghamshire Council again requesting that the work was done to get the area back to a presentable state prior to any agreement. Cllr Paul Bunce asked if the water quality could be tested, the Clerk to arrange if a test can be obtained at a reasonable cost.

The Committee requested that an asset tour be set up with a member of the grounds team accompanying, the Clerk to arrange.

- b) The Clerk reported that the stomping ground gate had been a success and that no further issues had been reported.
- c) The Clerk reported that all new equipment was now installed and online publicity of the equipment will take place this week.
- d) The Committee **RESOLVED** to install the barrier at the library entrance to the park as per the report.

#### RA23/010 Street Furniture and Public Conveniences

- a) The Committee discussed the idea of siting a bench in the bus shelter on the green, it was unclear if the bus stop was operating and the possible impact on antisocial behaviour was also raised. Cllr Akash Bagga is to obtain some further information and the item will be raised again at the next meeting.
- b) The Committee noted the new bench in Burnham Park and another that will shortly be placed near the orchard.

The Committee requested that any new signage for Burnham Park should include NO BBQs.

#### RA23/011 Repairs and Maintenance

The Council discussed the failing wooden sleepers surrounding the flower beds on the war memorial. Builders quotes were being obtained for replacing the wood with a brick wall. Cllr Graham Mummery suggested recycled plastic sleepers as an alternative and this will also be looked into. A discussion took place regarding funding for the work, the office will investigate the possibility of grant funding.

#### RA23/012 Climate Emergency

The Committee noted the improvements and changes that had been made since the previous meeting.

The nature park was briefly discussed and should be placed on any future project list.
