Dear Councillor

My apologies for the delay in getting a full response back to you. I was awaiting feedback on one of the points from a colleague who only works part-time.

1. Options are being considered for redevelopment and disposal of the site. These are still at an early stage.
2. The coach arrangement is a short-term facility governed by the lease with the Academy. The requirements within the lease will continue to be fulfilled and future arrangements will be reviewed alongside the options for the site.
3. We have spoken with Steve Nash of the Parish Council who suggests that there may be groups that could make use of the site for sporting activities, we are looking into how the site can be divided to facilitate this. We do not have details of the quantum of sporting activity to be accommodated yet and that information would be useful in developing these discussions.
4. The request from Burnham Lighthouse can be accommodated around the other meanwhile uses we have onsite to help mitigate our costs of holding the site. Whilst we are aware of the previous use by Burnham Lighthouse, we are not aware of any approach for this summer. It would be useful to have a main point of contact to help arrange this if there is the intention for this to go ahead.

5. We will continue to house any meanwhile activities that allow the council to recover some of the void holding costs of the site which includes filming activity.
