There had been issues in the heavy rain with the pond overflowing and an update was given that the lease was still with the legal department at Buckinghamshire Council. Cllr Paul Bunce asked about the stream in the grounds of the Opendale school site and requested that Bucks be asked to clear it again, it was reported that they had been asked many times with no response.

RA23/047 Street Furniture and Public Conveniences

The Committee noted the change of style for the bus shelter bench that had been approved at P&R and the install date of 8th December. The Committee **RESOLVED** to trial the bench for 6 months.

RA23/048 Repairs and Maintenance

It was reported that tractor tyres had been replaced.

RA23/049 Climate Emergency

The Committee noted the list and asked for 3-4 items to be selected as priority items to ensure that momentum continues, Cllr Paul Bunce to go through the list and advise on the selection. The Orchard was discussed as it is not flourishing and needs some TLC. The planting of some 'spikey' hedging was also discussed to go against the concrete wall at St Peters.

RA23/050 Healthy Walks around Burnham

Cllr Ekta Kaur Ross gave an update on the progress of the booklet and it was stated that due to the recent wet weather most of the walks still needed to be tested.

RA23/051 Village Green Pathway

The Committee discussed the idea of putting in a permanent pathway across the village green and the report prepared by the Clerk. It was agreed that this was a good idea and would stop the muddy pathway that appears each year. The Committee thanked the grounds staff for the idea and **RESOLVED** to recommend the pathway to BPMC at their next meeting.

RA23/052 George Pitcher Car Parking

The Committee discussed the idea of charging a fee to park for more than 30 mins at the George Pitcher Memorial Ground and the report prepared by the Clerk. Concerns were raised over cars parking on the road outside rather than paying the £1. It was **RESOLVED** to go ahead with the parking charges with the funds being used to improve the facilities at the site. The new charges would begin at the end of the current football season (May 2024).
