FC23/092 Finance

The Council noted the October management accounts with any significant variances explained by the Clerk. The Council **RESOLVED** to approve the October bank reconciliations and October summary of payments.

FC23/093 Budget

The Council voted to add £15k to the reserves in next years budget, after the hospitality rate relief scheme had freed up this money from the BPH budget. Cllr Ekta Kaur Ross voted against this in favour of reducing the precept request by £15k. The Council **RESOLVED** to approve the budget and it will be brought back to the Council for sign off once the tax base had been received from Buckinghamshire Council.

The Council **RESOLVED** to approve the biodiversity policy and action plan.

FC23/095 Working Groups

- a) Neighbourhood Plan Working Group Cllr Carol Linton gave an update and summarised the note that had been circulated from the consultant, all agreed that the way forward seemed most appropriate and were happy for the steering group to continue to work as per the note. The Chairman thanked the Clerk for her hard work in getting the Neighbourhood Plan moving again. b) New School Steering Group An update from the steering group chairman Viv Nicholas was read. Cllr Marie Hammon stated that she has now received a reply from Anita Cramer regarding a free school and she has replied to this. Cllr Linton reported that she and Cllr Dev Dhillon were arranging to visit the Pioneer school to explore how it can be better publicised to Burnham parents. Cllr Judith Foster expressed her concern over the carbon emissions of the coaches travelling out of Burnham daily and the time the children have to get up in the mornings to catch the coaches.
- c) Climate Emergency Working Group The Clerk reported on the progress with the new bank and explained that now most of the 'easy win' items had been completed the committees should be looking to prioritise a few of the more complex tasks for completion.

FC23/097 Reports from Buckinghamshire Councillors

Graham White from the Beeches Community Board was present and gave an overview of the history of the boards and the current remit. He stated he would be the contact for the board until at least March 2024 and the priorities for the current year were Infrastructure & Highways, The Environment and Health & Wellbeing. There was currently around £63k left unpent in the pot that could be allocated to appropriate projects, the board was now looking for match funding for all grants. Cllr Terry Gamble asked about the opportunity Bucks areas and how they had been decided upon, it was explained that the areas were selected after analysis of local deprivation figures and statistics.

Cllr Carol Linton reminded the Council that there would be an upcoming Bi-Election after the resignation of Cllr David Anthony.

FC23/098 Chairmans Report

The Chair, Vice-Chair and Clerk were invited to the launch of an exciting new augmented reality application to celebrate the completion of The Beacons of The Past project at Burnham Beeches on the 15thNovember. The AR app allows visitors to use their mobile phones or tablet devices to superimpose periods of Burnham Beeches history, such as the Iron Age, Middle Ages and WorldWar ll when the area was used by the army to hide vehicles before the D-Day landings. The Chair, as Chairman of Burnham and District Heritage Society chaired the AGM on the 16th November. Many local residents attended, including quite a few councillors and John Carey the Vice Chairman. The main event of the meeting was the showing of of the film 'Burnham Bells Ring for the King', featuring Cliff Blundell with the Tower and Handbell Ringers who are situated at St Peter's Church.
