<u>PL/24/3307/FA</u> - 9 Linkswood Road Burnham Buckinghamshire SL1 8AS Single storey rear extension, front porch extension and changes to existing fenestration. The committee **RESOLVED** to state that they had **NO OBJECTIONS**.

<u>PL/24/3310/VRC</u> - Grenville Lodge Hawthorn Lane Burnham Buckinghamshire SL2 3TE Variation of condition 2 (Approved plans) of planning permission 10/02043/XFUL (Extension of time limit of Planning Permission 08/00295/FUL for detached dwelling and garage.) to allow for amendments to design including additional dormers to facilitate second floor accommodation, an increase in the size of the garage and changes to windows/doors.

The committee **RESOLVED** to **OBJECT** to the proposed development. It was deemed out of keeping and out of character with the area. The committee noted that the proposal is subject to a presumption against development due to its proximity to Burnham Beeches, which could negatively impact local wildlife and species. The committee also raised concern that the development would be too urban for this rural area and could contribute to light pollution. The committee concluded that the proposal is unsuitable and inappropriate for the location.
